# Jason Miller



**Jason Miller**  
*CIGIE Executive Chairperson*

The Honorable Jason Miller is the CIGIE Executive Chairperson and the Deputy Director for Management at the Office of Management and Budget, where he serves as the Federal Government’s Chief Operating Officer. In this role, he coordinates Governmentwide management initiatives to protect, strengthen, and empower the Federal workforce and ensure a more equitable, effective, and accountable Federal Government that delivers results for all Americans. Toward these goals, Miller leads the development and implementation of the President’s Management Agenda as Chair of the President’s Management Council.

Miller also is carrying out the President’s commitment to deliver prosperity, security, and opportunity to all Americans—including through implementation of the American Rescue Plan to help families and businesses recover from the impacts of the COVID-19 pandemic and by harnessing the power of Federal procurement to support workers and manufacturers through the Made in America Initiative.

Most recently, Miller led the U.S. Trade Representative agency review team during the Biden-Harris transition. Prior to that, he was the Chief Executive Officer of the Greater Washington Partnership, which is a civic alliance of employers in the Capital Region focused on issues of regional inclusive economic growth and prosperity that included building and operating a more reliable and accessible transportation system; driving improved digital skills workforce through enhanced programs at the K-12, community college, and undergraduate levels; and improving housing affordability.

Previously, Miller served in the Obama-Biden White House as Deputy Assistant to the President and Deputy Director of the National Economic Council, where he led the Administration’s economic policy development and coordination related to manufacturing and innovation, transportation and infrastructure, energy, entrepreneurship, and Puerto Rico.

Prior to the Obama-Biden Administration, Miller was a management consultant with the Boston Consulting Group in San Francisco and with Marakon Associates in Chicago, where he advised large organizations across industries on strategic, financial, and organizational issues. Miller received a B.A. from the University of Pennsylvania, an M.B.A. from the Kellogg School of Management at Northwestern University, and an M.P.A. from Harvard’s Kennedy School of Government. Miller currently resides with his wife and three children in Maryland.

# Mark Lee Greenblatt

The Honorable Mark Lee Greenblatt began his tenure as the Inspector General for the Department of the Interior (DOI) on August 26, 2019, after being confirmed by the U.S. Senate. As the Inspector General, IG Greenblatt leads a nationwide workforce of investigators, auditors, evaluators, attorneys, and support staff.

In December 2022, IG Greenblatt was elected by the membership of the 74 Federal Inspectors General to serve as the Chairperson of the Council of the Inspectors General on Integrity and Efficiency. IG Greenblatt's two-year term as CIGIE Chairperson began on January 1, 2023. In this role, he leads the IG community's efforts to combat fraud, waste, and mismanagement throughout the Federal Government. From January 2021 to December 2022, IG Greenblatt served as the CIGIE Vice Chairperson.

IG Greenblatt has been in the Federal oversight community since 2003, serving in both the legislative and executive branches. Before becoming the DOI Inspector General, he served as the Executive Director of CIGIE. He previously held leadership roles at the Department of Commerce OIG and the U.S. Senate Permanent Subcommittee on Investigations. IG Greenblatt also served as an investigative counsel at the Department of Justice OIG.

IG Greenblatt served as a Federal law clerk, was a litigator at two large, international law firms, and is a published author.

IG Greenblatt graduated from Columbia University School of Law, where he was a Harlan Fiske Stone Scholar, and earned his undergraduate degree from Duke University. He also completed the Senior Managers in Government Fellowship at Harvard University's Kennedy School of Government.

# Tammy L. Hull

Tammy L. Hull serves as the Vice Chairperson of the Council of the Inspectors General on Integrity and Efficiency. CIGIE Chairperson Mark Lee Greenblatt appointed IG Hull to the position in January 2023.

The Governors of the U.S. Postal Service appointed IG Hull as the third Inspector General of the U.S. Postal Service on November 29, 2018. Prior to her appointment, IG Hull served as the Acting Inspector General for the U.S. Postal Service OIG since February 2016. She also served as the Deputy Inspector General from November 2011 to February 2016. In years prior, IG Hull served as the Assistant Inspector General for Audit. She joined the U.S. Postal Service OIG in November 2005 as an Audit Director.

IG Hull started her Government career at the Internal Revenue Service Inspection Service and transitioned with them as a part of the Treasury Inspector General for Tax Administration (TIGTA), established in early 1999. During her career at TIGTA, she was an audit manager in Dallas, Texas, for several years before moving to Washington, DC, as the Director of the Office of Management and Policy.

IG Hull holds a Bachelor of Accounting and Business Administration degree from W. J. Bryan College in Dayton, Tennessee, and is a Certified Public Accountant.

# James N. Mattis



**James N. Mattis**  
*Former U.S. Secretary of Defense*

The Honorable James N. Mattis served as the 26th Secretary of Defense in 2017 and 2018. In this role, he worked to strengthen America's alliances and reorient the defense budget to face the rising challenges posed by emerging technologies and near-peer adversaries.

During his 43 years in the Marine Corps, General Mattis commanded combat tours at the platoon, battalion, regiment, brigade, division, force, and theater levels. This included command of the 1st Marine Expeditionary Brigade in Afghanistan as part of Operation Enduring Freedom and of the 1st Marine Division during the invasion of Iraq in 2003. His time in the military culminated with 3 years as the Commander of U.S. Central Command where he oversaw joint efforts in Afghanistan and Iraq and helped shape U.S. policy toward Iran.

Immediately prior to this, he served simultaneously as the Commander of U.S. Joint Forces Command and the Supreme Allied Commander for Transformation. In these roles, he oversaw the transformation of capabilities for the U.S. military and NATO allied forces respectively. His major projects included efforts to reshape U.S. military doctrine to engage more effectively in irregular warfare and to reimagine the U.S. military's grand strategy.

Earlier in his military career, General Mattis served as the Executive Secretary of the Department of Defense during the tenures of Secretary William Perry and Secretary William Cohen and also as the Senior Military Assistant to Deputy Secretary of Defense Rudy de Leon.

Following his retirement from the U.S. Marine Corps in 2013, Secretary Mattis served as the Davies Family Distinguished Visiting Fellow at the Hoover Institution at Stanford University, specializing in the study of leadership, national security, strategy, innovation, and the effective use of military force.

He is currently the Davies Family Distinguished Fellow at the Hoover Institution at Stanford University where he lectures and writes on domestic and international security policy. He also serves as Senior Counselor at the Cohen Group, a member of the Board of Directors of General Dynamics, and a member of the Board of Directors of Tri-Cities Good Bank in his hometown of Richland, Washington.

# Kevin H. Winters



**Kevin H. Winters**  
*Amtrak Inspector General*

Kevin Winters became the Inspector General of Amtrak on January 31, 2019. Amtrak's Office of Inspector General (OIG) provides independent and objective oversight of Amtrak's programs and operations. Amtrak operates a nationwide rail network, serving more than 500 destinations in 46 states, the District of Columbia, and 3 Canadian provinces, on more than 21,400 miles of routes.

As an Inspector General, he is a member of the Council of the Inspectors General on Integrity and Efficiency. In May 2019, IG Winters was appointed to serve on its Integrity Committee, which receives, reviews, and refers for investigation, as appropriate, allegations of wrongdoing made against Inspectors General and other key personnel; and ensures the fair, consistent, timely, and impartial disposition of the allegations. In June 2020, IG Winters was elected to serve as the Integrity Committee's Chair.

Previously, he served as a senior executive with NASA OIG from 2005 through 2015. As NASA's Assistant Inspector General for Investigations, his staff of special agents, investigative auditors, and computer forensic examiners focused on allegations of fraud, waste, and abuse affecting NASA's programs. In coordination with the Department of Justice, his staff recovered more than \$650 million in civil and criminal fraud-related penalties, and his Computer Crimes Division spearheaded many successful investigations into international computer intrusions affecting NASA, which resulted in holding cyber criminals accountable in Europe, Africa, and Asia.

Before joining the OIG community, Kevin Winters served in the United States Marine Corps, retiring as a Brigadier General. His initial service was as an armor officer with the Second Marine Division, and then as a judge advocate after attending law school through the Funded Law Education Program. Subsequent domestic and overseas assignments included duties as a prosecutor and defense counsel; a faculty member at the U.S. Army's JAG School in Charlottesville, Virginia; a battalion commander at Parris Island Recruit Depot; and as a senior uniformed legal advisor to the Commandant of the Marine Corps, where his office was also responsible for providing legal support to over 172,000 Marines and their families. As an adjunct faculty member for the Defense Institute of International Legal Studies, Mr. Winters led instruction teams in the rule of law and civilian control of the military for senior civilian and military officials in the Republic of the Congo, the Czech Republic, the Philippines, Estonia, and the Republic of Ghana.

His final Marine Corps assignment was as an Assistant Judge Advocate General of the Navy, where, among other duties, he was a principal advisor for military justice policy for the Department of the Navy. He was also in the Pentagon on 9/11 and later served in Iraq.

Originally from Harrisburg, Pennsylvania, IG Winters has a Bachelor of Science in Commerce and a Juris Doctor degree from the University of Louisville and a Master of Laws from the University of Virginia.

# June Gibbs Brown Career Achievement Award

June Gibbs Brown was part of the first group of Inspectors General nominated by President Jimmy Carter and confirmed by the U.S. Senate after the passage of the Inspector General Act of 1978. She served as the first statutory IG of the Department of the Interior until 1981. That year, President Ronald Reagan nominated her to be the IG at the National Aeronautics and Space Administration, where she served for 4 years. In 1987, President Reagan again asked IG Brown to serve her country, this time as the IG for the Department of Defense.

IG Brown is most often remembered for her achievements as the IG of the Department of Health and Human Services, a position she held between 1993 and 2000. During her tenure, she oversaw the expansion of operations at both HHS and HHS OIG after the enactment of the Health Insurance Portability and Accountability Act of 1996. She later served as the first IG of the Social Security Administration when it was carved out of HHS.

In light of IG Brown's extensive contributions to the Federal oversight community, CIGIE presents this award to one person who has served for at least a decade in the IG community and who has made significant and sustained contributions that furthered the goals of the Inspector General Act throughout their career.

### Phyllis McKissick

*In recognition of 40 years of significant and sustained contributions to the success of the Department of Labor (DOL) OIG in combatting fraud, waste, and abuse in DOL programs and operations and in combatting labor racketeering in the American workplace.*

Throughout her 40-year career at the DOL OIG, Phyllis McKissick has made sustained, high impact contributions to its mission. Her impact on the office's investigative accomplishments during her tenure is clear: 18,222 indictments; 10,127 convictions; and over \$4 billion in investigative monetary results—many of which would not have been possible without her dedicated leadership and support. After beginning her career in 1982 as a clerk typist, McKissick has held numerous positions within the Office of Investigations, including Investigative Assistant, Management Analyst, and Branch Chief of Administrative Operations. She was most recently appointed to serve as the Office of Investigations Director of Administration in 2022. For many years, McKissick served as the preeminent expert in all administrative matters involving the DOL OIG's Office of Investigations and played a key role in overseeing its human resources, budgetary, and procurement functions. In addition to her technical expertise, McKissick is viewed by many as a consummate professional and an exemplary OIG employee.

# Barry R. Snyder Joint Award

The PRAC telehealth team, composed of partners from six OIGs (DOD, DOJ, DOL, HHS, OPM, and VA) and the PRAC, engaged in a groundbreaking collaboration during the COVID-19 pandemic. Their goal was to assess telehealth use across selected Federal health programs and the associated potential program integrity risks. Led by HHS OIG, the team used new tools to collaborate and issue a report.

Notably, the report revealed dramatic increases in telehealth use during the first year of the pandemic, when 37 million individuals used more than \$6 billion in telehealth services across the examined Federal programs. The report went on to identify and discuss the risks for fraud in the telehealth field, including the risk of billing for the same service twice, inappropriately billing the most expensive level of service, and billing for services that are not suitable for telehealth.

The team's work successfully highlighted for policymakers that looming decisions about the emerging future of telehealth flexibilities must balance changing consumer demand with necessary protections against fraud, waste, and abuse. Achieving this balance requires complete and reliable data, as well as additional safeguards to strengthen program integrity and minimize risk.

# Glenn/Roth Award for Exemplary Service

Senators John Glenn and William V. Roth, Jr., served together as the Chairman and Ranking Member of the U.S. Senate Committee on Governmental Affairs for many years, often trading positions when party control of the Senate changed. Approximately 3.5 million veterans may have been exposed to airborne hazards and toxins from open burn pits and other sources—exposure that has the potential to cause both immediate and delayed health problems. The Department of Veterans Affairs has struggled to provide benefits and care to veterans who developed disabilities related to exposure to burn pits.

The VA OIG team's evaluation of persistent errors in processing burn pit exposure benefit claims and their analysis of a broken registry exam process provided Congress with crucial data and compelling evidence to inform legislation addressing these problems. At the time, Congress was considering the PACT Act, which would make it easier for veterans to prove that burn pits caused their disabilities, provide toxic exposure screening to every veteran enrolled in VA health care, and improve research and treatment.

The PACT Act was signed by President Biden on August 10, 2022, and is perhaps the largest expansion of veterans' health care and benefits in history.

The international media recently reported that more than 30 women made over 50 allegations of widespread sexual exploitation and abuse (SEA) by personnel affiliated with the World Health Organization (WHO) in the Democratic Republic of Congo (DRC). Over an 18-month period, USAID OIG investigators and attorneys engaged with U.S. interagency counterparts to respond to these allegations. USAID OIG team members traveled to Geneva to encourage WHO officials directly to share information.

As a direct result of the team’s efforts, WHO shared hundreds of previously unreleased investigative documents. The USAID OIG investigation found substantiated widespread allegations of SEA, rape, and harassment (including against girls as young as age 13) by WHO staff and partners. The team also found that senior level WHO staff in Geneva were aware of the allegations but failed to take appropriate action.

Based on referrals by USAID OIG, USAID has debarred two individuals and suspended and proposed debarment of eight additional people responsible for the horrific assaults in the DRC. These are the first known U.S. Government debarments of U.N. officials determined to have engaged in SEA. They will protect other women and children by preventing these individuals from working on U.S. Government funded projects.

Over the course of a 2-year investigation, the AOC OIG Investigative Division revealed a series of egregious actions by the former Architect of the Capitol, including that he repeatedly abused his authority, treated Government property as his own, and wasted taxpayer money. For example, the former Architect permitted family members to drive AOC vehicles for personal vacations. During one excursion, the AOC car was involved in a minor accident and the former Architect represented to the other driver that he was an "agent" and that the Government would pay for the repairs (which it did). The AOC OIG team then uncovered evidence that the former Architect used an AOC vehicle equipped with emergency devices to pursue a hit-and-run suspect who struck his daughter's boyfriend's vehicle. Others involved in the accident, including local law enforcement, were under the impression that he was a Federal law enforcement officer.

The results of the AOC OIG investigative team's work led to bipartisan calls for the former Architect's resignation. Congress also included language in the Omnibus Appropriations bill to prevent Federal funds from being used for a home-to-work vehicle for the Architect. President Biden removed the former Architect in February 2023.

Assistant Special Agent in Charge Jon-Paul Correira is a leader both within HHS OIG and across the CIGIE community. When he began working at HHS OIG’s headquarters as the Director of Policy and Inspections, he established and co-chaired the CIGIE Policy Developers Working Group to share materials and coordinate knowledge of IG policies and procedures.

To further continuing education and encourage information sharing across the CIGIE investigative community, Correira also organizes semiannual meetings to discuss and learn about relevant and timely topics, including legal and constitutional issues; health, safety, and protection matters; emerging threats; and other evolving issues. For these meetings, he has recruited speakers from across the Government, including the Department of Justice, the Executive Office of the President, the Office of Personnel Management, and the Federal Bureau of Investigation, as well as from OIGs across the community.

When President Biden issued Executive Order No. 14074, *Advancing Effective, Accountable Policing and Criminal Justice Practices to Enhance Public Trust and Safety*, Correira drew on his depth of leadership experience and skills to help the OIG investigative community. He created a timeline for distribution to all working group members showing due dates for the executive order’s requirements. After drafting HHS OIG’s policy updates, he then shared these as examples for others. He also joined two interagency working groups developing guidance required under the executive order. Lastly, he worked with representatives from DOJ, HHS, EOP, and OPM to provide presentations to the Assistant Inspectors General for Investigations Committee and the CIGIE Policy Developers Working Group on their roles and views on the reporting requirements under the new executive order. These presentations were incredibly helpful and allowed CIGIE members to be better positioned to meet their new responsibilities under the executive order.

# Sentner Award for Dedication and Courage

On June 21, 2006, Special Agent William Sentner III of the DOJ OIG was working with the FBI on an investigation involving corrupt prison guards in a Federal prison in Tallahassee, Florida. As a result of the investigation, six prison guards were indicted for sexually abusing female inmates, smuggling contraband into the institution, and threatening the inmates with retaliation if they exposed the criminal acts.

Special Agent Sentner was part of the joint DOJ OIG-FBI team that went to the prison to arrest the six guards. At the prison, as one of the guards was being arrested, he produced a gun from his bag and began firing. The guard first shot a prison lieutenant and then shot Special Agent Sentner. Before the guard was able to fire at other personnel, Special Agent Sentner returned fire, fatally wounding the guard. Special Agent Sentner saved the lives of several other law enforcement officers while sacrificing his own, as he later died of his wound.

On October 22, 2008, President George W. Bush honored Special Agent Sentner by posthumously awarding him the Medal of Valor, the highest national award for a public safety officer. Today, CIGIE bestows the Sentner Award for Dedication and Courage on an individual or group who demonstrates uncommon selflessness, dedication to duty, or courage while performing OIG duties.

In August 2019, the U.S. Government launched Joint Task Force Vulcan (JTFV), an initiative to disrupt, dismantle, and destroy the international criminal organization known as MS-13. Special Agent Phillips joined the JTFV in 2021 as the sole representative of USAID OIG, focusing on investigating allegations of U.S. Government funding and personnel involved in MS-13 activities.

Phillips has been an integral part of the task force, participating in several joint temporary duty assignments, including many abroad. She represented USAID OIG exceptionally well and provided critical support to the U.S. Government's efforts. Moreover, Phillips learned valuable new investigative techniques that she brought back and shared with her USAID OIG colleagues, helping to ensure that the office will have additional opportunities for success in the future.

# Alexander Hamilton Award

Alexander Hamilton was one of our country’s most influential Founding Fathers. He dedicated much of his life to public service, including as an aide-de-camp to General George Washington during the Revolutionary War, a representative at the Constitutional Convention, and Secretary of the U.S. Treasury, where he laid the foundation for our modern banking system. A lesser-known fact is that after Hamilton left his government positions in the 1790s, President Adams and former President Washington asked Hamilton to serve his country once more as tensions with France rose and the threat of war grew. As a result, Hamilton was the Inspector General of the United States Army from 1798 to 1800. Throughout his long career, IG Hamilton demonstrated a commitment to building and sustaining strong government structures and programs. In recognition of his accomplishments and his legacy, CIGIE presents this award to the individual or group who demonstrates outstanding achievements in improving the integrity, efficiency, or effectiveness of agency operations. The Alexander Hamilton Award constitutes CIGIE’s highest recognition.

### Team for Deficiencies in Lethal Means Safety Training, Firearms Access Assessment, and Safety Planning for Patients with Suicidal Behaviors by Firearm

*In recognition of the team’s rigorous review of the medical records of 480 patients with suicidal behavior events, VA policy, staff training, and survey results of over 3,000 clinicians to identify actions needed to prevent veterans’ deaths by suicide.*

Approximately 17 veterans die by suicide daily, and 7 in 10 of those are from firearm injuries. Increasing the time and distance between a person in crisis and their access to firearms can save lives. The VA has made eliminating veteran suicide its top clinical priority.

The VA OIG team evaluated VA care providers’ completion of required lethal means safety (LMS) training on simple interventions that educate and encourage veterans and caregivers to use safe firearms storage practices, which are critical in preventing suicide.

The team made seven recommendations to facilitate suicide prevention by enhancing oversight, provider training, and lethal means assessments and interventions, while reducing barriers to firearms access discussions. As a result of their work, the VA is taking important steps to improve lethal means suicide prevention. These include convening subject matter experts to update the VA’s national policy on suicide prevention training, strengthening the LMS curriculum, and amending VA medical record templates to ensure care providers assess, discuss, and document firearms access and safe storage concerns with veterans.

# Remembering Our Colleagues

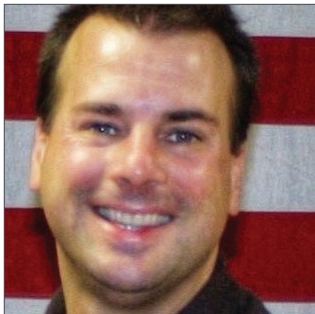


**David L. Hunt**  
*Inspector General, Federal  
Communications Commission*

David L. Hunt served as the Inspector General of the Federal Communications Commission (FCC) from 2011 to 2023, after serving as the Acting Inspector General for nearly 2 years. He first joined the FCC in 1996 as an attorney-advisor in the Pricing Division of the former Common Carrier Bureau, where he helped implement some of the most complex provisions of the 1996 Telecommunications Act.

From 1999 to 2006, he was a senior attorney in the FCC's Enforcement Bureau where he managed formal complaints and conducted investigations, including a 2-year investigation of abuses within the Telecommunications Relay System. In early 2006 he joined the FCC's Office of Inspector General as the Assistant Inspector General for Investigations.

During his time at the FCC and FCC OIG, IG Hunt was awarded the FCC Gold Award as well as Excellence in Investigations Awards from CIGIE's predecessor organizations. Prior to joining the FCC, he worked as a trial attorney at several national law firms in Washington, DC, and Los Angeles, California, representing major national corporations in complex antitrust and regulatory proceedings. IG Hunt passed away on January 10, 2023.



**Richard M. McGrade**  
*Senior Special Agent, DOT OIG*

Senior Special Agent Richard M. McGrade served with distinction for over 21 years in the Department of Transportation (DOT) OIG's New York City Office. Rich began his long law enforcement career as a New York City Police Officer in 1993 before becoming a Deputy U.S. Marshal in 1996. In 1999, he served as a Special Agent with the Coast Guard Investigative Service and then transferred to DOT OIG in 2002. Rich was an aggressive investigator, who was well respected by his peers and prosecutors alike. He secured numerous criminal convictions, trial successes, and civil monetary recoveries. A native of Queens, New York, Rich was a devout Mets fan. Rich passed away on May 10, 2023. He will be remembered for his integrity, sense of humor, and dedication to his friends and family.



**Hubert N. Sparks**  
*Inspector General, Appalachian  
Regional Commission*

Hubert N. Sparks served in the U.S. Army and later began a 50-year distinguished career working for the U.S. Government. He was appointed as the first Inspector General of the Appalachian Regional Commission (ARC) in 1989, where he worked until 2002. In 1999, he was appointed to concurrently serve as the first Inspector General of the Denali Commission. In addition to his work pioneering independent oversight at the ARC and the Denali Commission, IG Sparks served 29 years in oversight roles with the Offices of Inspector General for the Departments of Agriculture, Homeland Security, and Veterans Affairs. IG Sparks returned to the ARC to again serve as its Inspector General in 2011.

During his long career in the OIG community, IG Sparks served as the first Vice Chairperson of the Executive Council on Integrity and Efficiency, a predecessor to CIGIE. He also worked closely with CIGIE's other predecessor, the President's Council on Integrity and Efficiency, serving as the only Designated Federal Entity IG on it for a number of years. He was a member of CIGIE and was active in the Audit and Inspection & Evaluation Committees. IG Sparks also started a working group, which continues to meet today, that served as a forum where small OIGs could come together to discuss their shared challenges. IG Sparks passed away on June 6, 2023.
