If selected for an in-person interview, the ODNI hiring office will pay for travel by commercial carrier (economy class) or reimburse for privately owned vehicle (POV) mileage. If applicable, the candidate also will be reimbursed at a flat rate for commercial lodging and per diem.

Position Information

This is an opportunity for:

- An internal or external candidate to fill a GS-15 cadre position.
- A Federal Government employee to serve on a two-year reimbursable detail assignment in the ODNI. The detail assignment may be extended an additional year if all parties agree.

Who May Apply

Current GS employees at the same grade as the advertised position grade may apply.

Former members of the Peace Corps may be considered for ODNI employment only if five full years have elapsed since separation from the Peace Corps.

- For a cadre assignment:
 - Current ODNI permanent cadre.
 - Current ODNI Staff Reserve Employees. (A staff reserve employee who currently occupies this position may not apply.)
 - Current Federal Government employees. (Current GS employees at the same grade as the advertised position grade may apply.)

- For a detailee assignment:
 - Current Federal Government employees. (Current GS employees at the same grade as the advertised position grade may apply.)

Salary Determination

- The ODNI uses a rank-in-person system in which rank is attached to the individual. A selected ODNI candidate or other Federal Government candidate will be assigned to the position at the employee's current GS grade and salary.
- For a selected non-Federal Government candidate, salary will be established within the salary range listed above, based on education and experience.
- A current Federal Government employee, selected for a detail, will be assigned to the position at his or her current grade and salary.

Component Mission

The Inspector General (IG) conducts, supervises, and coordinates inspections, audits, investigations, and reviews relating to the programs and operations over which the Director of National Intelligence has authority and responsibility.

Major Duties and Responsibilities (MDRs)

- Serve as the Branch Chief for the Evaluations Branch and supervise a branch comprised of officers ranging from GS-13 to GS-15.
- Lead a team of professional staff and assess performance, collaborative and oversee goal setting, and provide feedback on personal development.
- Lead professional staff in the planning, development, and presentation of written documents, including reports of inspection, memoranda to management, and other documents, and also lead staff in the development and presentation of oral briefings for senior leaders regarding findings and the status of complex inspections.
- Lead staff in monitoring and assessing the progress of corrective measures taken by senior ODNI and IC leadership, and in providing substantive advice and innovative solutions to senior officials regarding implementation of recommendations.
- Lead the design of and conduct interviews, define data collection requirements, collect and analyze data and records, and synthesize information to develop findings, conclusions and recommendations; develop final reports, present finding and follow-up on recommendations.
- Represent the Evaluations Branch in strategic and annual planning activities in support of the Assistant Inspector General (AIG) and the Deputy Assistant Inspector General (DAIG).
- Recommend topics for cross IC and Intelligence Oversight Evaluations.
- Brief the results of evaluations as required to senior leaders in the Intelligence Community and Congress.
- Participate, as required, in Peer Reviews of other Inspection elements in Offices of Inspectors General in the Intelligence Community.
- Manage the Evaluations Branch in accordance with the Council of Inspectors General on Integrity and Efficiency (CIGIE) Quality Standards on Inspection and Evaluation.

- Successful completion of CI polygraph and background investigation.
- Successful completion of a ODNI medical screening.
- A two-year trial period is required for all new permanent appointments to the ODNI.
