Summary Statement

The Federal Communications Commission Office of Inspector General (FCC OIG) is seeking a highly motivated, high-performing Supervisory Auditor to serve in a reimbursable 6-month detail as Acting Assistant Inspector General for Audits, Inspections, and Evaluations (Acting AIG - AI&E). This position is full-time, in person at FCC OIG's office located at 45 L Street, NE, in Washington, DC, near NOMA/Union Station.

To qualify for this position, applicants must have served in an audit, evaluations, or inspection capacity within an Office of Inspector General for at least 5 years, must currently encumber a General Schedule-15-0511 supervisory position within the IG community, and must have served in a supervisory position in an OIG office of audits, evaluations, or inspections.

FCC OIG is an exciting place to work. In addition to a complex portfolio of audits, evaluations, inspections and reviews our office has a strong history of proactive work aimed at preventing fraud, waste, and abuse. We perform oversight for a diverse set of important programs aimed at promoting connectivity, ensuring national security and more. We are looking for a dynamic candidate to help enhance our audit, evaluations, inspections, and review enforcement capabilities.

Beyond technical capabilities and expertise, the candidate must possess excellent collaboration, oral and written communication skills, and a deep knowledge of OIG audit, evaluation, and inspection programs, policies, procedures, operations, OIG statutes, and best practices. FCC OIG conducts audits, evaluations and inspections. The Acting AIG-AI&E must also require minimal supervision and be able to manage teams working on organization- wide projects.

Summary of Duties:

The Acting AIG will lead and oversee FCC OIG's Office of Audits and report directly to the Inspector General (IG).

- Lead and supervise a team of approximately 15 staff in carrying out several contracted and in-house audits, evaluations and inspections.
- Consult with stakeholders, including agency management, the Office of Management and Budget, the Government Accountability Office, and Congressional officials.
- Help develop proposals for long-range and current audits, evaluations, inspections and reviews operations of the Commission programs and activities, including the contracting of audit work to Certified Public Accounting firms.
- Ensure FCC OIG's compliance with various statutory and regulatory audit requirements and with Congressional requests.
- Personally, and through the IG, keep agency officials informed of all significant findings and recommendations for appropriate action.
- Lead effort to follow up on open recommendations and report the status and progress of such recommendations to FCC leadership, congressional stakeholders and the public.
- Carry out agile work, as warranted, to maximize transparency around issues identified by audits, inspections, and evaluations.
- Lead the conduct of audits/evaluations/inspections/reviews as may be requested by the IG regarding unusual situations having agency-wide implications.
- Ensure that FCC OIG is prepared for all peer reviews, both audit and inspections and evaluations, to make certain that audit staff respond timely to all peer review requests.
- Further, ensure that any findings resulting from external peer reviews are addressed in Office of Audits, Inspections, and Evaluations operations in a timely manner.
- Ensure that the division meets the goals and objectives established by FCC OIG's Strategic Plan, and the measures set forth in FCC OIG's Performance Plan.

Highly Recommended Competencies

- Comprehensive knowledge of professional standards and techniques, and understanding of laws, precedents, and regulations governing audits.
- Advanced leadership training and experience.
- Demonstrated skill in oral communications.
- Expert knowledge of audits, evaluations, and inspections.
- Strong supervisory and managerial knowledge, skills and abilities in order to efficiently and effectively lead audits, evaluations, and inspections operations.
- Established record of leading and coordinating nationwide or agency-specific audit, evaluation, or inspection programs.
- Exceptional skill in written communications.
- Professional certifications such as Certified Public Accountant (CPA), Certified Inspector General (CIG), or Certified Inspector General Auditor (CIGA) are highly desirable.
