- Program Cost Tracking System (PCTS)
  - Postal database to facilitate project planning and monitoring of a contract's financial welfare
  - Centralized reporting tool for suppliers to provide contractor timekeeping
  - Tracks contractor employees' hours and costs by contract and delivery order
  - Not used on FFP contracts






## Project Objective

- Utilize data analytics to identify various labor cost mischarging fraud schemes, including:
  - Billing more than 80 hours per pay period
  - Billing hours simultaneously on multiple contracts/DO's
  - Billing at a rate higher than qualified for
  - Billing for onsite rates when offsite (COVID-19 pandemic)
- 2. Research correlation between billing hours and periods of performance for suppliers with both FFP and T&M contracts
  - Moving FFP costs or resources to T&M invoices at end of year

    - Determined significant billing for labor services for which the employee did not have requisite education or experience



### • Tripwire 3-Weekends and Holidays

- Excessive billing at end of periods of performance
- Uncommon billing on weekends and holidays

- IG Community Project Objective
  - 1. Collaborative analysis to determine shared vendors and potential cost mischarging fraud schemes, including:
    - Employees billing more hours than possible per pay period
    - Employees billing hours simultaneously on contracts from different agencies
    - Moving costs from one agency to another
  - 2. Research correlation between billing hours and contract periods of performance for potential machine learning
