Footnote Legend

¹ The Board of Governors of the Federal Reserve System IG was established as an independent oversight authority for the Consumer Financial Protection Bureau under the Dodd-Frank Wall Street Reform and Consumer Protection Act of 2010 (Dodd-Frank Act).

² Prior to December 2005, the Inspector General of the Appalachian Regional Commission (ARC) served as the Inspector General of the Denali Commission through a Memorandum of Understanding between the ARC IG and the Denali Commission Federal Co-Chair.

³ Although Mr. Schornagel was appointed Inspector General effective March 12, 2001, the Library of Congress OIG became a statutory office on August 2, 2005, with the enactment of the Library of Congress Inspector General Act of 2005. As a statutory (civilian) IG appointed by the Agency head, the Library of Congress OIG also became an ECIE member on that date.

⁴ The Office of the Special Inspector General for Iraq Reconstruction (SIGIR) is the successor to the Coalition Provisional Authority Office of Inspector General (CPA-IG). SIGIR was created in October 2004 by the congressional amendment to Public Law 108-106, triggered by the June 28, 2004, dissolution of the CPA. Mr. Bowen had also served as the IG for the CPA-IG (appointed January 20, 2004).
